

DE C R E E No. 15/1998
of the Ministry of Economy of the Slovak Republic
of 19 December 1997

on the conditions for granting official licence to import and export goods and services

The Ministry of Economy of the Slovak Republic under § 56, para 1, subparagraph b), of the Act No. 42/1980 Col. on foreign economic relations within the meaning of the Act No. 102/1988 Col. and the Act No. 113/1990 Col. provides:

§ 1

(1) Goods listed in Schedules A, B, C, D and E may only be imported to or exported from the Slovak Republic based on, within the scope and under conditions established in a official licence (hereinafter referred to as a "licence"). The licence shall be granted by the Ministry of Economy of the Slovak Republic (hereinafter referred to as the "Ministry").

(2) Lists of goods set out in Schedules A, B, C, D and E hereto and the extent of limitations on imports and exports shall be laid down by the Ministry. With respect to goods defined as 01 to 24 and 4401 to 4403 of the Customs Tariff¹, they shall be fixed as may be proposed by the Ministry of Agriculture of the Slovak Republic (hereinafter referred to as the "Ministry of Agriculture"), with respect to goods defined as 2505 to 2530 and 6901 to 6908 of the Customs Tariff, they shall be fixed as may be proposed by the Ministry of Construction and Public Works of the Slovak Republic (hereinafter referred to as the "Ministry of Construction").

(3) Lists of goods and the extent of limitations contained therein shall be laid down by the Ministry in compliance with international obligations of the Slovak Republic.

(4) The Ministry may make in the course of the year alterations to the lists of goods according to paragraph 1 and the scope contained therein. It shall publish such alterations in the Gazette of the Ministry. Alterations to the lists of goods and the extent of limitations on goods defined as 01 to 24 and 4401 to 4403 of the Customs Tariff shall be published by the Ministry following discussions thereon with the Ministry of Agriculture, and goods defined as 2505 to 2530 and 6901 to 6908 of the Customs Tariff shall be published by it following discussions with the Ministry of Construction.

§ 2

(1) No licence shall be required to import or export goods not being commercial in nature.²

(2) No licence shall be required to import or export goods set out in Schedules A, B, C and D insofar as it concerns

- a) Slovak or foreign goods being commercial samples in nature and being proposed for export or free circulation treatment³,
- b) foreign goods being proposed for customs treatments with a conditional exemption from duty or for regimes with economic effects, excluding active refining relations regime within the return system,³⁾
- c) Slovak or foreign goods being proposed for export or free circulation treatment, if it is provably substitute goods to be supplied for faulty goods reclaimed,
- d) Slovak or foreign goods being proposed for export or free circulation regime that is provably part of investment units including construction work,
- e) Slovak goods being proposed for export regime contained in a reexported refined product that is the result of processing operations within the active refining relations treatment,
- f) Slovak goods being proposed for free circulation regime provably returned from abroad⁴,
- g) Slovak goods being proposed for export regime to be returned to abroad that has been refused by a domestic importer as a defective goods or goods not complying with the terms of a contract under which it has been imported,
- h) foreign goods in reexportation.

(3) No licence shall be required to import or export goods set out in Schedule E hereto insofar as it concerns

- a) Foreign goods being proposed for transit treatment,
- b) goods being proposed for active refining relations regime within a conditional system or passive refining relations,³⁾
- c) goods being proposed for temporary use regime, if the recipient is a central authority of state administration,
- d) goods consumer in nature and designed for use in international military exercises or for use under the mandate of U.N. operations or designed for testing and the recipient is a central authority of state administration.

§ 3

(1) For the purposes of this Regulation, it shall be understood by

- a) the licensing procedure a procedure by the Ministry in making decisions on applications for licensing,
- b) the automatic licence a licence serving the purpose of keeping files on imports or exports,
- c) the non-automatic licence a licence to import or export goods which quantity or other limit applies to.

(2) An automatic licence shall be granted to any applicants meeting the conditions hereunder, for a certain kind of goods, a certain quantity or value and for a period of time as may be established. An automatic licence shall be granted for importation or exportation of goods set out in Schedule A Part II or Schedule B Part II hereto.

(3) The applicant shall not have title to being granted a non-automatic licence. A non-automatic licence shall be granted for a certain kind of goods, a certain quantity or value and for the established period of time such that importation or exportation of such goods conforms with the trade policy interests and international obligations of the Slovak Republic and that a

sum of the licenced quantity or value for a certain goods does not exceed the annual quantity as laid down herein. A non-automatic licence may be granted to import or export goods set out in Part I of Schedule A, Part I of Schedule B and Schedules C, D and E hereto.

§ 4

(1) The licensing procedure shall be effected by the Ministry on the basis of an application in writing made by the applicant.

(2) The licence applicant may be a corporate body with its registered office in the Slovak Republic or a natural person with his permanent residence and principal place of business in the Slovak Republic entitled to business.

(3) A licence application shall contain

- a) commercial name and registered office with respect to a corporate body, and commercial name and place of business with respect to a natural person doing business under a trade licence or other business authorisation,
- b) applicant identification number,
- c) identification number, commercial name and registered office of a corporate body or commercial name, permanent residence and place of business of a natural person who is a producer of goods, unless the applicant is a producer of goods to be exported,
- d) Customs Tariff item number for goods to be imported or exported,
- e) name of goods, quantity and par value thereof,
- f) proposed licence validity period,
- g) name of origin state while importing goods or name of destination state while exporting goods.

(4) Model application forms are set out in Schedules F, G, H and I hereto.

(5) A certified copy of the certificate of incorporation, where the applicant is a corporate body, and a certified copy of the trade licence or other business authorisation, where the applicant is a natural person, shall be added to the licensing application by the applicant. These documents shall not be older than twelve (12) months and shall not be required to be enclosed with repeated applications made by the applicant in the calendar year.

(6) A copy of a purchase or other contract for delivery of goods concluded with a foreign contractor or consumer shall be added to the non-automatic licensing application by the applicant.

(7) For goods referred to in Schedule E hereto, the applicant shall indicate a domestic customer identification number when importing, and a foreign customer name and registered office and a certificate of goods final user when exporting.

(8) The goods import licensing application shall be complete with documents certifying the quality and wholesomeness of goods under special regulations⁵.

(9) The Ministry may seek with the applicant other documents relating to imports or exports applied for in order to review the import or export licensing application.

§ 5

(1) There shall be no time limits to making licensing applications.

(2) An automatic licensing application shall be decided on by the Ministry within fourteen (14) days of the delivery of such full application.

(3) An application for non-automatic licensing to import or export goods set out in Schedules A, B, C and D hereto shall be decided on by the Ministry within thirty (30) calendar days of the delivery of such full application, while taking care that licences granted do not exceed yearly import or export quantities laid down in Schedules A, B and C hereto. In deciding on a non-automatic licensing application, the Ministry shall also take account of the amount of previous imports or exports by the applicant, the rate of utilization of licences granted thereto over previous periods, as well as the rate of utilization of licences granted to other persons importing or exporting the same kind of goods.

(4) Applications for granting a non-automatic licence to import or export goods defined as 01 to 24 and 4401 to 4403 of the Customs Tariff and set out in Schedules A, B and C hereto shall be decided upon by the Ministry following discussions with the Ministry of Agriculture.

(5) Applications for granting a non-automatic licence to import or export goods listed in Schedule E hereto shall be decided on by the Ministry within sixty (60) days of the delivery of such full application.

(6) The Ministry may not grant a licence to that applicant who has failed to comply with the terms and conditions or the import or export extent as established in the licence granted thereon over the previous period or who has broken universally binding bylaws in connection with imports or exports of goods with respect to which it is applying for a licence.

(7) The Ministry may not grant a non-automatic licence insofar as significant trade policy, ecological, health, safety or other significant interests of the Slovak Republic so require.

§ 6

(1) A licence-holder shall be held responsible for meeting the conditions set out in the licence.

(2) A licence-holder shall not transfer a licence granted thereon to any other persons.

(3) A licence-holder shall give, within fifteen (15) days of the date on which it became aware of circumstances preventing imports or exports from being effected, a notice to that effect to the Ministry, and the former shall return a licence granted on the latter. The Ministry may grant such unused licence to other applicant.

(4) A licence-holder shall return a licence granted on it to the Ministry within fifteen (15) days of the termination date thereof.

§ 7

(1) The Ministry may withdraw an automatic licence granted as long as it has been granted on the grounds of false data or the terms and conditions as established therein have not been adhered to.

(2) The Ministry may withdraw a non-automatic licence insofar as

- a) it has been granted on the grounds of false data,
- b) terms and conditions established therein or the scope of imports or exports have not been complied with,
- c) significant trade policy, ecological, health, safety or other significant interests of the Slovak Republic so require.

(3) The Ministry shall be held responsible for any damages sustained or incurred by the applicant or the licence-holder through non-granting or withdrawing a licence.

§ 8

(1) A customs authority shall not release goods listed in Schedules A, B, C, D and E for a proposed customs regime until a declarant or a representative thereof has submitted along with the customs declaration an original copy of the licence issued for the commercial name of the declarant or, in the case of indirect agency, for the commercial name of a person represented.

(2) A customs authority shall only release goods listed in Schedules A, B, C, D and E for a proposed customs regime on the basis of a licence which is valid on the date of acceptance of the customs declaration.

(3) A customs authority in releasing goods for a proposed regime shall certify on the back of an original copy of the licence or enclosures thereto certified by the Ministry a quantity and value of actually released goods as established in the licence.

(4) A customs authority shall only release for a proposed customs regime such quantity of goods that exceed neither quantity nor value indicated in the licence. In so doing, it shall take account of quantities and values indicated on the back of the licence in previous customs procedures.

§ 9

This Regulations repeals the Regulation of the Ministry of the Slovak Republic No. 30/1995 Col. concerning the conditions for granting official licence to import or export of goods and services within the meaning of the Regulation of the Ministry of Economy of the Slovak Republic No. 101/1996 Col., the Regulation of the Ministry of Economy of the Slovak Republic No. 158/1996 Col., the Regulation of the Ministry of Economy of the Slovak Republic No. 23/1997 Col., the Regulation of the Ministry of Economy of the Slovak Republic No. 118/1997 Col., the Regulation of the Ministry of Economy of the Slovak Republic No. 159/1997 Col. and the Regulation of the Ministry of Economy of the Slovak Republic No. 374/1997 Col.

§ 10

This Regulation takes effect on the date of promulgation.

- A1 Description of goods - state the name.
- A2 Customs Tariff item number - in each application form state only one Customs Tariff item number
- A3 Specification of goods - state the name of such Customs Tariff item under which the goods set out in A1 is to be imported / exported.
- A4 Use purpose - state an approximate method of use, e.g. in army, security branches, in manufacture, for collection purposes, completion, internal trade, for other unspecified use.
- A7 Price in OP - state in Sk the value of commercial parity when conversed according to the prevailing exchange rate on the date of filling in the application form.
- A8 FCO Slovak borders - state FCO Slovak borders in Sk.
