STATUTORY INSTRUMENTS

1995, No. 13

**External Trade (Import Prohibition) Order 1995, made by  
the Minister under section 3 of the External Trade Ordinance, Cap. 361.**

1. This Order may be cited as the External Trade (Import Prohibition) Order, 1995. Short title.
2. (1) The import without a licence granted under section 4 of the External Trade Ordinance (Cap. 361) of goods from or originating in any country or place not listed in the First Schedule is prohibited. Restriction of import from certain countries.
- (2) Goods shall be deemed to have originated in a country if they are wholly produced or manufactured in that country.
3. (1) The import without a licence of goods listed in the Second Schedule is prohibited unless the goods are imported from a member country of the Organization of Eastern Caribbean States (OECS) or from the Caribbean Common Market (CARICOM). Restriction of import of certain goods.
- (2) The import without a licence of goods listed in the third Schedule is prohibited unless the country of origin is a member of the Organization of Eastern Caribbean States (OECS).
4. Nothing in this Order shall be construed as authorising the import of goods, the entry of which is prohibited or restricted under any other law in force in Antigua and Barbuda. Order subject to other laws.
5. The following Orders are revoked — Revocation.
- (a) The Union of South Africa (Import Prohibition) Order 1960 (SR&O 1960/17).
- (b) The External Trade (Import Restriction) Order 1975 (SR&O 1975/8).
- (c) The External Trade (Import Restriction) (Amendment) Order, 1977 (SR&O 1977/3).

- (d) The External Trade (Import Restriction) (Amendment No. 2) Order, 1977 (SR&O 1977/31).
- (e) The External Trade (Import Restriction) (Amendment) Order, 1978 (SR&O 1978/44).
- (f) The External Trade (Import Restriction) Order, 1978 (SR&O 1978/45).
