**PART I : SECTION (I) – GENERAL**

**IMPORT AND EXPORTS (CONTROL) ACT, NO. 1 OF 1969**

REGULATIONS made by the President under section 20 read with section 14 and subsection (3) of section 4 of the Imports and Exports (Control) Act, No.1 of 1969, and paragraph (2) of Article 44 of the Constitution.

**R E G U L A T I O N S**

1. (1) These regulations may be cited as the Special Import Licence and Payment Regulations, No. 1 of 2011 and shall come into operation on January 2, 2012.

(2) The Special Import Licence Regulations, No. 1 of 1977 published in *Gazette Extraordinary* No. 291/7 of November 15, 1977, as amended from time to time and as last amended by regulation published in *Gazette Extraordinary* No. 1733/10 of November 21, 2011, are hereby repealed:

Provided that notwithstanding such repeal, all licences issued under the provisions of any regulation which so repealed shall continue to be valid and effectual as if such licences had been issued in terms of this regulation in so far as is required for the purpose of discharging the rights and obligations contained therein.

2. (1) The Goods described in Schedule I to these regulations are goods in respect of which an import licence authorizing the import thereof, issued by the Controller of Imports and Exports in terms of the provisions of the Import Control Act, No. 1 of 1969, is required. The persons, to whom an import licence for the import of any item of goods specified in Schedule I may be issued, shall be such persons as are specified in Schedule II to these regulations.

(2) The import of any item of goods specified in Schedule I to these regulations shall where such goods are for commercial purposes, be subject to the terms and conditions relating to payment terms as are specified in the provisions of these regulations as are hereinafter set out.

(3) The import of any item of goods for commercial purposes which is not specified in Schedule I to these regulations and for which no import license is required in terms of the Imports and Exports Control Act, No 1 of 1969, shall however be subject to the terms and conditions relating to payment terms as are specified in the provisions of these regulations as are hereinafter set out.

3. (1) Payment terms for imports may, for the purposes of these regulations be classified as -

- (a) payment made prior to the date of submission of the required Customs Declaration (hereinafter in this regulation referred to as "CUSDEC") to the Director - General of Customs, where imports are made on the basis of payment terms relating to Advance Payment (Cash in Advance), Documents against Payment, Documents against Acceptance and Letters of Credit, or a combination of these;
- (b) payment made subsequent to the submission of the CUSDEC to the Director - General of Customs, in respect of imports made under Payment Terms relating to Open Account Basis and Consignment Account Basis;
- (c) payment made by adopting a mode of payment comprising a combination of (a) and (b) above.

(2) The choice and technicalities of the Payment Terms to be adopted in respect of any particular import is a matter to be decided as between the person who is the Supplier and the Importer of the goods and the relevant licensed commercial bank (hereinafter referred to as "the Bank).

4. All banks shall assign a unique number to each transaction and notify the Sri Lanka Customs Department of all information regarding each transaction relating to, or made under, the number so assigned.

5. Every Importer shall declare the unique number assigned under regulation 4 above when submitting the CUSDEC for the clearance of cargo.

6. An Advance Payment (Cash-in-Advance) which is --

(1) made out of a Sri Lanka rupee account -

(a) where the amount of the advance payment required to be made on the total value of goods to be imported, does not exceed a sum of United States Dollars Fifty Thousand (US\$50,000) or its equivalent in any other convertible foreign currency, shall be allowed in terms of these regulations ; and

(b) where the amount of the advance payment required to be made on the total value of the goods so imported, exceeds the sum of United States Dollars Fifty Thousand (US\$50,000), or its equivalent in any other convertible foreign currency, then the advance payment shall be effected only on:-

(i) the submission of a bank guarantee or a standby Letter of Credit for the value of the amount of the Advance Payment, acceptable to the bank effecting such Advance Payment; or

(ii) the submission of the Value Added tax (VAT) Registration number, the Tax Identification number (TIN) and any other documents which the Controller of imports may require having regard to the particular transaction to the Controller of Imports and Exports for his approval given after considering the merits of the respective transaction; or

- (2) made out of a foreign currency account, then the limits specified in paragraph (1) (a) and (b) above shall not be applicable thereto.

7. The limit specified in paragraph (1) (a) and (b) of regulation 6 of these regulations shall not be applicable in relation to any Advance Payments being made for the import of Gold (HS Code 71.08) and Platinum (HS Code 71.10), where the application for the remittance is certified by the National Gem and Jewellery Authority, established by the National Gem and Jewellery Authority Act, No. 50 of 1993.

8. (1) An Importer shall not effect payment for the import of goods under Advance Payment, unless the importer ensures that all goods in respect of which payment is to be made for, are brought into Sri Lanka within a period not exceeding one hundred and eighty days (180) from the date of remittance of such payment:

Provided that where the goods, referred to in paragraph (1) of this regulation is "Machinery and Heavy equipment", such goods should reach the country within a period not exceeding three hundred and sixty five days (365), from the date of remittance of the advance payment.

(2) An Importer shall not effect any payment for the import of goods under a combination of Advance Payment and a Letter of Credit, unless the importer ensures that all goods in respect of which payment is to be made for, are brought into Sri Lanka within a period not exceeding three hundred and sixty five days (365), from the date of remittance of such payment.

(3) Where the enforcement period goes beyond the period which is specified in (1) and (2) above, the goods or part thereof, should be brought into Sri Lanka within the period covered by the Bank guarantee or the standby Letter of Credit as the case may be, or within seven hundred and thirty days (730) from the date of remittance of the advance payment, whichever occurs first.

9. (1) No payment should be made on unpaid import bills relating to the goods imported under Documents of Acceptance (D/A bills) after one hundred and eighty days (180) from the date of maturity, without the prior written permission of the Controller of Imports and Exports having been obtained in respect of such payments.

(2) It shall be the duty of every Bank to furnish details of unpaid import bills relating to goods imported under Documents of Acceptance (D/A bills) on a monthly basis to the Controller of Imports and Exports, where such bills are *not settled* by the Importer within one hundred and eighty days (180) days from the date of maturity.

10. (1) All shipping documents in relation to goods imported under the terms of payment referred to in regulation 3(1)(a) of these regulations, other than those relating to Advance Payment, shall be forwarded by the supplier's bank or by the supplier of the goods to a bank, prior to the goods so imported being released to the importer.

(2) The bank may at its discretion accept the documents which are directly forwarded to the importer, after satisfying itself of the authenticity of such shipping documents.

(3) In the event of the original shipping documents not being received on time, bank may at its discretion permit the importer to submit copies of such documents for uploading to the Sri Lanka Customs website by the bank in order to facilitate clearance of the goods. The importer shall thereupon arrange for the original shipping documents to be forwarded to the relevant bank within forty five (45) days from the date on which copies of the CUSDEC were uploaded to Sri Lanka Customs website. On receipt of the original documents the bank shall verify the originals against the copies of documents previously submitted by the importer. Where the originals do not correspond to the copies of documents submitted by the importer, the bank shall forward copies of both sets of documents to the Director General of Customs, for necessary action. The Bank shall be required to submit to the Director General of Customs a monthly report of cases where the original documents are not submitted within the stipulated period.

(4) Where the original Bill of Lading has been surrendered, the importer shall submit the Delivery Order collected from the shipping line to the bank for uploading to Sri Lanka Customs by the Bank, in order to facilitate clearance of goods.

(5) The Shipping documents referred to in this regulation shall include: -

- (a) the Invoice (any invoice relating to the goods imported, other than the *Pro forma* Invoice); and
- (b) the relevant transport documents.

11. (1) Where the payment for goods imported for commercial purposes is to be made after the submission of CUSDEC as specified in regulation 3 (1)(b) of these regulations,-

- (a) the respective payment shall be made within three hundred and sixty five days (365) from the date of submission of CUDSEC;
- (b) return of goods to the supplier shall allowed in terms of the provisions of an

agreement entered into by the importer with the overseas supplier, provided no payment has been made on the respective goods to be returned: Provided that if a payment has been made, the approval of the Director General of Customs shall be obtained for the return of goods;

(2) On clearance of goods, the CUSDEC Number shall be the unique number by which such transaction shall be identified.

(3) Sri Lanka Customs Department shall upload and provide access to information relating to these transactions (Customs Declaration Number, Name of Importer and outstanding amount) on their website to the Bank with reference to the CUSDEC Number.

(4) All banks shall verify the outstanding amount due on any transaction by accessing the Sri Lanka Customs Department website, before making any payment in relation thereto.

(5) The bank making a payment shall upload details of any payment to the Director – General of Customs under the CUSDEC Number and the Banks own unique Number relating to such payment, on the same day that such payment was made.

(6) The Sri Lanka Customs Department shall deduct the amount of any such payment made and thereupon display the current outstanding amount against each transaction on the website.

12. Where the payment is in respect of goods imported for commercial purposes as specified in sub - paragraph (c) of paragraph (1) of regulation 3 –

- (a) the provisions of regulations 4, 5, 6, 8, 9 and 10 of these regulations; and
- (b) the provisions of regulation 11,

shall be applicable thereto.

13. (1) The provisions contained in regulations 1 to 12 above shall have no application in respect of goods imported through a Courier Service and cleared through the Console (Block) Customs Declaration. However, the declarant on behalf of the importer shall declare the individual value in the CUSDEC against the respective House Airway Bill in the following format:-

"DECLARATION OF THE COURIER SERVICE PROVIDER

We hereby certify that the amount of .....  
(amount in foreign currency) has been declared in the Master  
CUSDEC Number:.....in respect of this house Airway  
Bill.

(2) The bank shall accept the copy of the House Airway Bill endorsed by the courier Company to make the remittance, where the value of the any goods imported does not exceeds Five Thousand United States Dollars US\$ 5000), or its equivalent in any other convertible foreign currency and the importer makes a declaration to that effect in the following format:-

"DECLARATION OF THE IMPORTER TO THE BANK

I/We (name of the Importer).....hereby confirm that  
the amount relating to the Airway Bill has not been remitted.

(3) Where the amount to be paid for an House Airway Bill is less than One Thousand United States Dollars (US\$ 1000), no documents shall be required by the Bank, to make such payment.

14. The provisions of regulations 3 to 13 of these regulations shall not apply -

(a) to import of goods for personal use of the importer (not in commercial quantities) where the value of the consignment does not exceeds United Stated Dollars five Thousand (USD 5000) or its equivalent in other convertible foreign currencies. In the case of such imports,-

(i) documentary proof of payment including bank memos shall be furnished to the Director General of Customs along with the clearance documents;

- (ii) the Director General of Customs on being satisfied that the requirements of paragraph (i) above has been complied with, may release such goods.
- (b) to goods imported without payment in foreign exchange out of Sri Lanka (NFE basis) where value in the aggregate does not exceed United States Dollars five thousand (US \$ 5000) or its equivalent in any other convertible foreign currency.
- (c) to goods, which exceed in value United States Dollars Five Thousand (US\$ 5000) or its equivalent in any other convertible currency, imported without payment in foreign exchange out of Sri Lanka (NFE basis), the Director General of Customs may release such goods on the tender by the importer, of the relevant clearance documents along with a declaration to the effect that such goods are for the purpose of re-export:

Provided however, in relation to goods that do not involve re-export, the Director General of Customs may release such goods upon obtaining information and being satisfied, of the reasons for such import.

15. The provisions referred to in paragraphs (a), (b) and (c) of regulation 3 (1) of these regulations shall not apply to the import of goods specified in the Column I of Schedule III and falling within the Harmonized System [(HS) Code] specified in the corresponding entry in Column II of the table, where-

- (a) the import of such goods into Sri Lanka does not involve a payment in foreign exchange out of Sri Lanka and the Director General of Customs may release the goods on the tender of the relevant clearance documents by the Importer which shall contain a Declaration to the effect that the goods are imported for re-export; and
- (b) the import of goods into Sri Lanka is on a consignment basis and the importer, -
- (i) declares to the National Gem and Jewellery Authority established by the National Gem and Jewellery Authority Act, No. 50 of 1993, the quantity, value of the goods and the purpose of the import of such goods;



- (ii) complies with the conditions imposed by such Authority; and
- (iii) satisfies the Director - General of Customs that the requirements of paragraphs (i) and (ii) above have been complied with, prior to the clearance of such goods from the Sri Lanka Customs.

16. The importation of Motor Vehicles falling under HS Code No's 87.02, 87.03, 87.04 and 87.05 should be made only by Letters of Credit (LC's) which should be opened prior to shipment of the relevant motor vehicle. The conditions stipulated by the Central Bank of Sri Lanka for the establishment of Letters of Credit (L/C) in respect of any category of items falling within the aforementioned HS Codes, shall be applicable.

17. Director- General of Customs shall compare the details furnished by the bank with the CUSDEC relating to each individual import, and identify the incidents where goods have not been imported within stipulated period, against payment made. The Director General of Customs shall forthwith report such incidents -

- (a) in case of an importer which is an Enterprise which has been registered under the Board of Investments of Sri Lanka Law, No 4 of 1978, to the Controller of Imports and Exports; and
- (b) in case of an importer which is not an Enterprise which has been registered under the Board of Investments of Sri Lanka Law, No 4 of 1978, to the Controller of Exchange.

18. The Controller of Exchange and the Controller of Imports and Exports shall, in consultation with the Director General of Customs and the relevant commercial banks, monitor the payments made in terms of regulation 3 to regulation 17 of these regulations and take such steps as are required by law in relation to situations where goods have not been imported within the stipulated period, against the payment made.

19. The Controller of Imports and Exports, may at his discretion grant any waiver from the application of the provisions of these regulations to any person on an application made to him by such person.

20. The Controller of Imports and Exports shall from time to time issue Operating

Instructions to the Director General of Customs and banks with a view to the prudent and efficient implementation of these regulations.

21. Where any person who being the Declarant or the Importer as the case may be, acts in violation of the provisions of these regulations, the Director General of Customs, shall on his own accord or in consultation with the Controller of Imports and Exports, take action as provided for by law.

22. Where any Bank acts in violation of the provisions of these regulations, the Director General of Customs shall forthwith notify the Controller of Exchange and the Controller of Imports and Exports of such fact and shall also forward the details of such violations along with all documentary evidence relating thereto to them. The Controller of Exchange and the Controller of Imports and Exports shall take action as provided for in law or inform the relevant authority to take for appropriate action, as the case may be.

23. In these regulations –

“time of importation” shall mean the actual date of arrival of the vessel or landing of aircraft, which carries the consignment of goods to Sri Lanka;

“enterprise which has been registered under the Board of Investments of Sri Lanka Law” shall mean an enterprise with which an agreement has been entered into by the Board of Investment of Sri Lanka under section 17 of the Board of Investment of Sri Lanka Law No. 4 of 1978 and has been granted exemption from the provisions of the Exchange Control Act (Chapter 422) ;

“furnish of details” shall mean providing of details of the payment made by the commercial bank or goods released by Director General of Customs, as the case may be, in accordance with the specific instructions issued by the Controller of Imports and Exports for this purpose, including content, mode and procedure and time of submission, that each party is required to adhere to, when furnishing such details;

“import of goods for personal use” shall mean goods that are imported by an importer specified in Schedule II, in non- commercial quantities and such importer declares that there is no intention to resell such goods which are imported for the exclusive use of such importer;

“foreign currency accounts” shall mean any foreign currency account maintained at the Domestic Banking Unit (DBU) through which outward remittances are allowed for current international transactions (irrespective of whether debits for imports were permitted or not), or Off-shore Banking Unit (OBU/FCBU) of a commercial bank which operates in Sri Lanka in accordance with instructions issued by the Controller of Exchange or the Monetary Board of the Central Bank of Sri Lanka, as the case may be;

“machinery and heavy equipments” means any ‘machine or heavy equipment’ that shall be directly used to enhance the capacity and/or operational efficiency of the importer and the useful period of such machine or heavy equipment as declared by the importer, shall not be less than (three years 3);

“CUSDEC Number” shall mean the reference number allocated by Sri Lanka Customs Department at the time of registration of the Customs Declaration (CUSDEC). The number is a combination of the Year, Office Code, Registration Series Letter and Registration Number. (e.g 2011 CBLR1 I 12345678).
